The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): October 28 and 29, 2015

During the course of the inspection, the inspector(s) spoke with the Director of Care, the Registered Dietitian, one Personal Support Worker, one Registered Nurse, one Registered Practical Nurse, one Family member and two Residents.

The inspector also made observations of residents and care provided. Relevant policies and procedures, as well as clinical records and plans of care for identified residents were reviewed.

The following Inspection Protocols were used during this inspection: Food Quality Personal Support Services Reporting and Complaints Sufficient Staffing

During the course of this inspection, Non-Compliances were issued.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,

(a) the planned care for the resident; 2007, c. 8, s. 6 (1).

(b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).

(c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

## Findings/Faits saillants :

1. The licensee has failed to ensure that the plan of care set out clear directions to staff and others who provide direct care to the resident.

Record review of the current care plan for Resident # 001 revealed the focus related toileting did not provide clear direction to the Personal Support Workers (PSW) providing this care.

Record review of the Minimum Data Set (MDS) Assessment revealed the Urinary Incontinence and Indwelling Catheter Resident Assessment Protocol (RAP) stated the resident was on a toileting schedule.

Interview with the PSW revealed Resident # 001 was routinely toileted. The PSW confirmed the current care plan/kardex stated that the resident was not toileted and this was inaccurate.

Interview with the Director of Care on October 29, 2015 confirmed it was the home's expectation that plan of care sets out clear directions to staff and others who provide direct care to the resident. [s. 6. (1) (c)]

#### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the plan of care set out clear directions to staff and others who provide direct care to the resident, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 26. Plan of care Specifically failed to comply with the following:

s. 26. (3) A plan of care must be based on, at a minimum, interdisciplinary assessment of the following with respect to the resident:
21. Sleep patterns and preferences. O. Reg. 79/10, s. 26 (3).

## Findings/Faits saillants :

1. The licensee has failed to ensure that the plan of care was based on an interdisciplinary assessment of the resident's sleep patterns and preferences.

Record review of the "Complaint Information Report" revealed Resident # 001's family member had concerns related to the resident's sleep and rest preferences.

Staff interview with the Personal Support Worker (PSW) confirmed there were no interventions related to the resident's sleep and rest patterns.

Record review of the current care plan revealed there were no goals or interventions related to Resident # 001's sleep and rest patterns and preferences. The PSW confirmed the kardex was the point of reference for PSWs and documentation in the kardex related to care and services were absent of interventions for Resident # 001's sleep and rest periods as per the resident's preferences. [s. 26. (3) 21.]

## Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the plan of care was based on an interdisciplinary assessment of the resident's sleep patterns and preferences, to be implemented voluntarily.
