**During the course of the inspection, the inspector(s) spoke with the Administrator, Manager of Resident Care, Resident Care Coordinators, Minimum Data Set - Resident Assessment Instrument (MDS-RAI) Coordinator, Manager of Business Operations, Registered Nurses, Registered Practical Nurses, Personal Support Worker, Consultant Pharmacist, a Pharmacy Student and residents.**

**The inspector also toured the home, observed care provision and staff to resident interactions, drug destruction of controlled substances, shift to shift count of controlled substances, reviewed risk management reports, internal investigative notes, residents' clinical records, training records related to falls prevention, meeting minutes and relevant policies and procedures.**
