The purpose of this inspection was to conduct an Other inspection.

A post-occupancy inspection was conducted following the completion of a newly built 4 story, 128 bed building for long term care residents.

During the course of the inspection, the inspector(s) spoke with the Director, Environmental Services Supervisor, Food Services Supervisor and registered and non-registered staff

During the course of the inspection, the inspector(s) toured all 4 floors and the basement, common areas, bathing areas, resident rooms, laundry, kitchen and the outdoor courtyard, observed supplies, furnishings, fixtures and tested the stairwell and perimeter door alarm system, resident-staff communication and response system, lighting levels and hot water temperatures.
