**Log #007646-19 - related to medication administration.**

**A compliance order (CO) was served on March 25, 2019 as a result of complaint inspection #2019\_665551\_0001, in relation to medication administration. The due date for the CO was June 24, 2019. A change of licensee occurred on April 1, 2019. The new licensee has a condition on the transfer of the licence that the new licensee complies with all outstanding orders made against the previous licensee. As a result of this inspection, no findings of non-compliance related to medication administration were noted.**

**During the course of the inspection, the inspector(s) spoke with the Director of Resident Care (DRC), the Manager of CQI and Risk, the Registered Nurse Resource Manager, Registered Nurses (RN), Registered Practical Nurses (RPN).**

**During the course of the inspection, the inspector reviewed health records, the licensee and pharmacy's policies related to medication administration, medication management system, medication incidents, adverse drug reactions, the pharmacy's medication management orientation training package and interviewed registered staff and management.**
