During the course of the inspection, the inspector(s) spoke with Activity Aides, a Restorative Care Aide, Registered Nurses, the RAI coordinator and the Director of Care.

During the course of the inspection, the inspector(s) made resident observations, conducted observations of resident areas, reviewed resident health care records, reviewed home policies related to head injury routine and home procedures related to resident outings.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 212.

Administrator

Specifically failed to comply with the following:

s. 212. (1) Every licensee of a long-term care home shall ensure that the home's Administrator works regularly in that position on site at the home for the following amount of time per week:

- 1. In a home with a licensed bed capacity of 64 beds or fewer, at least 16 hours per week. O. Reg. 79/10, s. 212 (1).**
- 2. In a home with a licensed bed capacity of more than 64 but fewer than 97 beds, at least 24 hours per week. O. Reg. 79/10, s. 212 (1).**
- 3. In a home with a licensed bed capacity of 97 beds or more, at least 35 hours per week. O. Reg. 79/10, s. 212 (1).**

1. The licensee has failed to comply with O. Reg 79/10, s. 212 (1) 3 whereby the home does not have an Administrator working regularly in that position for the required amount of time each week.

In an interview with the Director of Care, Sue Woodcock advised the previous Administrator was terminated approximately one month ago. In the interim, Woodcock has been appointed the Acting Administrator and is currently performing both the duties of the Director of Care and the Administrator until a replacement is found. The Family Council minutes dated October 9, 2013 were reviewed and indicated the same information.

Perth Community Care Centre is a 121 bed, long term care home. In accordance with the legislated requirements, a home with a licensed bed capacity of 97 beds or more shall ensure the Administrator works regularly in that position on site at the home for at least 35 hours per week. Additionally, the Director of Care, in a licensed bed capacity of 65 beds or more is required to work at least 35 hours per week and therefore, cannot assume the role of the Administrator simultaneously. Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure an Administrator is working regularly in that position on site at the home at least 35 hours per week, to be implemented voluntarily.
