Specifically failed to comply with the following:

- s. 44. (9) If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,**
(a) the ground or grounds on which the licensee is withholding approval; 2007, c. 8, s. 44. (9).
(b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; 2007, c. 8, s. 44. (9).
(c) an explanation of how the supporting facts justify the decision to withhold approval; and 2007, c. 8, s. 44. (9).
(d) contact information for the Director. 2007, c. 8, s. 44. (9).

Findings/Faits saillants :

1. The licensee has failed to ensure that when an approval for admission was withheld, a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care were provided to the applicant, the Director and the appropriate placement co-ordinator.

A review of the bed refusal letter provided by the home, revealed that the home withheld the approval of an application due to the home's current resident care needs and lack of physical facilities necessary to manage the care of the applicant.

Interview with Administrator #100 and Director of Care (DOC) #101 revealed that there was no detailed explanation to support the reason for refusal provided to the applicant, the Director and the appropriate placement co-ordinator. [s. 44. (9) (b)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that when an approval for admission was withheld, a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care were provided to the applicant, the Director and the appropriate placement co-ordinator, to be implemented voluntarily.
