An inspection (2014-189120-0066) was previously conducted on October 15, 2014 at which time non-compliance was identified and Orders issued with respect to door security (Order #001), the resident-staff communication and response system (Order #002) and lighting levels (Order #003). For this follow-up inspection, Order #001 is being revised to reflect the outstanding non-compliance.

During the course of the inspection, the inspector(s) spoke with the Environmental Services Supervisor. Stairwell doors and activation stations were tested and lighting levels were measured.

- 1. All doors leading to stairways and the outside of the home other than doors leading to secure outside areas that preclude exit by a resident, including balconies and terraces, or doors that residents do not have access to must be,**
 - i. kept closed and locked,**
 - ii. equipped with a door access control system that is kept on at all times, and**
 - iii. equipped with an audible door alarm that allows calls to be cancelled only at the point of activation and,**
 - A. is connected to the resident-staff communication and response system, or**
 - B. is connected to an audio visual enunciator that is connected to the nurses' station nearest to the door and has a manual reset switch at each door.** O. Reg. 79/10, s. 9. (1).
- 2. All doors leading to non-residential areas must be equipped with locks to restrict unsupervised access to those areas by residents, and those doors must be kept closed and locked when they are not being supervised by staff.** O. Reg. 79/10, s. 9; O. Reg. 363/11, s. 1 (1, 2).
- 3. Any locks on bedrooms, washrooms, toilet or shower rooms must be designed and maintained so they can be readily released from the outside in an emergency.**
- 4. All alarms for doors leading to the outside must be connected to a back-up power supply, unless the home is not served by a generator, in which case the staff of the home shall monitor the doors leading to the outside in accordance with the procedures set out in the home's emergency plans.** O. Reg. 79/10, s. 9; O. Reg. 363/11, s. 1 (1, 2).

1. The licensee did not ensure that all doors leading to stairways and to unenclosed outdoor areas were equipped with an audible door alarm that allowed calls to be cancelled only at the point of activation.

The main entrance sliding doors and the stairwell doors (to which residents had access) were not equipped with a door alarm. Several different doors were tested on each floor with the Environmental Services Supervisor (ESS) to confirm the function of each door. Each door was connected to a separate audio visual enunciator panel on each floor (near the resident-staff communication and response system panel) which emitted an audio signal that the stairwell door remained open, but ceased to sound once the stairwell door closed. The ESS confirmed that the main sliding doors were also equipped in the same manner. The requirement to ensure that the door alarm could only be cancelled at each door was not met in addition to the fact that each door was not equipped with a door alarm. [s. 9 (1)]

 - (c) allows calls to be cancelled only at the point of activation; O. Reg. 79/10, s. 17 (1).
 - (d) is available at each bed, toilet, bath and shower location used by residents; O. Reg. 79/10, s. 17 (1).
 - (e) is available in every area accessible by residents; O. Reg. 79/10, s. 17 (1).
 - (f) clearly indicates when activated where the signal is coming from; and O. Reg. 79/10, s. 17 (1).
 - (g) in the case of a system that uses sound to alert staff, is properly calibrated so that the level of sound is audible to staff. O. Reg. 79/10, s. 17 (1).

Findings/Faits saillants :

1. The licensee did not ensure that an activation station(a component of the resident-staff communication and response system) was available in every area accessible by residents.

The licensee was previously required to install activation stations in various areas of the home, including the outdoor terrace. At the time of inspection, the outdoor terrace did not have an activation station that could be used by staff or residents to alert others that assistance was required on the terrace. [s. 17(1)(e)]

The licensee shall complete the following:

1. Equip all stairwell doors (to which residents have direct access) with an audible alarm at each door (either at the keypad or general vicinity).
2. Equip both main sliding entrance doors with an audible alarm (either at the key pad or general vicinity).
3. Ensure that the alarms sound at each stairwell door and main entrance door and corresponding enunciator panel 15-30 seconds after the code on the key pad to each door is entered to release the magnetic locking system. The alarm delay can be extended and will be dependent on the time it takes for the door to self close and for the average person to exit or enter.
4. Instruct staff that stairwell alarms can only be de-activated at each door by re-entering the key pad code and that when an alarm sounds, a staff member must investigate the stairwell or main door area for residents who may have exited the door without staff awareness.

Grounds / Motifs :

1. The licensee did not ensure that all doors leading to stairways and to unenclosed outdoor areas were equipped with an audible door alarm that allowed calls to be cancelled only at the point of activation.

The main entrance sliding doors and the stairwell doors (to which residents had access) were not equipped with a door alarm. Several different doors were tested on each floor with the Environmental Services Supervisor (ESS) to confirm the function of each door. Each door was connected to a separate audio visual enunciator panel on each floor (near the resident-staff communication and response system panel) which emitted an audio signal that the stairwell door remained open, but ceased to sound once the stairwell door closed. The ESS confirmed that the main sliding doors were also equipped in the same manner.
