WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 71. Menu planning Specifically failed to comply with the following:

s. 71. (4) The licensee shall ensure that the planned menu items are offered and available at each meal and snack. O. Reg. 79/10, s. 71 (4).

Findings/Faits saillants :

1. The licensee has failed to ensure that the planned menu items were offered and available at each meal and snack. On December 15, 2014, the therapeutic menu for Monday, week 2 indicated that there was to be puree textured custard pie offered and available as an alternate dessert choice for those on a pureed textured diet. During the first sitting on second and fourth floors, the puree textured custard pie was not available as confirmed with the dietary aide on second floor on December 15, 2014. The dietary aide called down to the kitchen, however, it was not brought up to the second floor until the first sitting was finished and therefore approximately ten residents on a puree textured diet were not offered the alternate dessert option. Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all of the therapeutic menu items are offered and available, to be implemented voluntarily.
