**The purpose of this inspection was to conduct a Complaint inspection.**

**Item #2-Dignity, choice and privacy not maintained.**

**Item #3-Food production.**

**Item #4-Dining and snack service.**

**Item #5-Air temperature not maintained.**

**Item #6-Attending Physician not allowed to care for resident's medical needs.**

**During the course of the inspection, the inspector toured the home, conducted interviews with the Director of Care's, Registered Nurses, Registered Practical Nurses, Dietitian, Cooks, Dietary staff, personal support workers and residents. Observed the provision of care to resident #001 including meal service and snack service. Observed staff interaction with the resident while providing care. Reviewed resident #001's clinical record from admission including resident's care plan, progress notes, physician orders, pain assessments, skin assessments and medication and treatment administration records. Reviewed other relevant documents including, but not limited to: policies and procedures related to skin and wound, meeting and investigation reports from the home.**

**During the course of the inspection, the inspector(s) spoke with Administrator, Director of Cares (DOC's), Nurse Clinician, Registered Staff, personal support workers (PSWs), dietary staff, Dietitian, cooks, maintenance staff and residents.**
