**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): June 1, 2, 6, 7, 8, 9, 12, 13, 14, 15, 20, 21, 22 and 23, 2017.**

**During this inspection the following logs were inspected: Log #019620-16 related to s. 19(1)-duty to protect from abuse/neglect and Log #020560-16 related to r. 30(2) – any action taken with respect to a resident under a program is documented.**

**This Follow-up Inspection was conducted concurrently with a Critical Incident Inspection and a Complaint Inspection.**

**Non-Compliance related to s. 19(1) was identified while completing the concurrent Critical Incident Inspection and has been re- issued as non-compliant with a Compliance Order on that inspection report (2017\_587129\_0007) with a link to the previous compliance order issued on Resident Quality Inspection #2016\_322156\_0006.**

**During the course of the inspection, the inspector(s) spoke with residents, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), 2 Directors of Care (DOC), Resident Assessment Instrument-Minimum Data Set Coordinator, Education Lead, Quality Improvement Coordinator and the Administrator.**

**During the course of this inspection the home was toured, resident's clinical records were reviewed, resident care was observed, policy and procedure documents were reviewed, program documents were reviewed, training records were reviewed and other documents maintained by the home were reviewed.**
