The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with O. Reg 79/10, s. 233. Retention of resident records

233. (1) Every licensee of a long-term care home shall ensure that the record of every former resident of the home is retained by the licensee for at least 10 years after the resident is discharged from the home. O. Reg. 79/10, s. 233 (1).

(2) A record kept under subsection (1) must be kept at the home for at least the first year after the resident is discharged from the home. O. Reg. 79/10, s. 233 (2).

Findings:

The licensee of the long-term care home did not ensure that the record of every former resident of the home is retained for at least 10 years after the resident has been discharged from the home.

Resident #001 was discharged from the home in 2012.

The home was not able to locate a complete hard copy of the resident's clinical health record, on request, for the purpose of this inspection.

The Director of Care confirmed on January 11, 2013 that despite attempts the home was unable to produce the former resident's clinical health record.
