Specifically failed to comply with the following:

Findings/Faits saillants :

1. The licensee failed to ensure that the plan of care was reviewed and revised when the resident's care needs changed.

A) The resident sustained a fall in April 2014 at the home and was transferred to hospital. The resident returned from hospital the same day. No discharge information or instructions related to the specific care for the resident was provided by the hospital, other than a prescription. The home contacted the hospital and requested discharge care instructions for the resident the day the resident returned to the home, but were not provided with any information. The home received reports from the hospital which confirmed the resident's injury three days after they first requested the discharge information from the hospital.

B) Registered staff who cared for the resident after their return from hospital confirmed during interviews that they directed PSWs to support the resident's injured area. Interviews with PSWs who worked during this period confirmed this information was provided to them related to the care of the resident and was carried out.

C) It was noted that the document the home refers to as the care plan, was not reviewed and revised to include interventions to manage the injury until three days after the resident returned from hospital.

D) Although the care plan related to the resident's injury was revised on the same day the home received the resident's hospitalization reports and discharge diagnosis in April 2014, other parts of the care plan were not revised when the resident's needs changed.

E) The DOC confirmed during an interview that the entire care plan should have been reviewed and revised as required when the resident's care needs changed. [s. 6. (10) (b)]

If the Licensee decides to request a hearing, the Licensee must, within 28 days of being served with the notice of the Director's decision, give a written notice of appeal to both:
