(b) a resident exhibiting altered skin integrity, including skin breakdown, pressure injuries, skin tears or wounds,

(i) receives a skin assessment by an authorized person described in subsection (2.1), using a clinically appropriate assessment instrument that is specifically designed for skin and wound assessment,

The licensee has failed to ensure that a resident who had skin integrity concerns was assessed using a clinically appropriate assessment tool.

On a specific date a resident had a fall and sustained abrasions as a result no clinical appropriate assessment tool of the skin abrasion was utilized. In an interview with staff it was confirmed that the Skin and wound assessment should of been completed as the clinically appropriate assessment tool of the skin abrasions.

The licensee has failed to ensure that skin abrasions sustained in a fall by a resident were reassessed weekly by an authorized person.

On a specific date a resident had a fall and sustained skin abrasions which were documented but not scheduled for reassessment in the treatment record for staff to follow up on. The treatment of the skin abrasion was complete, as confirmed in an interview with staff but not documented.
