WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 241. Trust accounts

Specifically failed to comply with the following:

s. 241. (4) No licensee shall,

(a) hold more than \$5,000 in a trust account for any resident at any time; O. Reg. 79/10, s. 241 (4).

(b) commingle resident funds held in trust with any other funds held by the licensee; or O. Reg. 79/10, s. 241 (4).

(c) charge a resident, or a person acting on behalf of a resident, a transaction fee for withdrawals, deposits, or anything else related to money held in trust. O. Reg. 79/10, s. 241 (4).

Findings/Faits saillants :

1. A sample of resident account activity was examined for the prior 6 month period. The account balances for two residents in the sample had at more than one point exceeded \$5,000 in these months. Further resident sampling was undertaken and no additional instances of account balances exceeding \$5,000 were discovered. The longest period observed for exceeding the account limit was 17 days; in all instances the reason that the balance limit was exceeded was due to the timing of deposits made to pay for specific monthly service charges.

The issue of the timing of deposits by resident substitute decision makers was discussed with the Administrator. [s. 241. (4) (a)]
