**Specifically failed to comply with the following subsections:**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits sayants :**

1. The care plan indicates that resident is not to be left unattended for toileting. Resident shared that staff do not stay with her all the time and 2 Personal Support Workers shared that resident is aware, able to ring the call bell and they do not stay in the washroom with the resident.
