The purpose of this inspection was to conduct a Complaint inspection.

Log #019970-20, was related to a complaint regarding resident care.

This inspection was completed concurrently with Critical Incident System inspection #2020\_750539\_0025.

During the course of the inspection, the inspector(s) spoke with the Chief Operating Officer, the Manager of Cognitive Care, the Programs Manager, the Clinical Auditor, the Registered Dietitian (RD), RAI Coordinators, Registered Nurses (RN), Registered Practical Nurses (RPN) and Personal Support Workers (PSW).

During the course of the inspection, the inspectors toured the home, and reviewed clinical health records, relevant home policies and procedures, and other pertinent documents.

- 1. A change of 5 per cent of body weight, or more, over one month.
- 2. A change of 7.5 per cent of body weight, or more, over three months.
- 3. A change of 10 per cent of body weight, or more, over 6 months.

# Findings/Faits saillants :

1. The licensee has failed to ensure that a resident's weight changes were assessed using an interdisciplinary approach, and that actions were taken and outcomes were evaluated when a change of more than five per cent of body weight occurred over one month and compromised their health status.

A resident had a weight loss of 12 kilograms (kg) over a nine week period.

A monthly weight taken on week four was thought to be inaccurate, struck out and not retaken until the end of the nine weeks.

No reassessment was documented and no new interventions were added.

A resident's weight loss was not assessed using a multidisciplinary approach, so no new actions could be taken or the outcome evaluated sooner.

## Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that residents with the following weight changes are assessed using an interdisciplinary approach, and that actions are taken and outcomes are evaluated: 1. A change of 5 per cent of body weight, or more, over one month. 2. A change of 7.5 per cent of body weight, or more, over three months. 3. A change of 10 per cent of body weight, or more, over 6 months. 4. Any other weight change that compromises the resident's health status, to be implemented voluntarily.
