The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 10, 11, 12, 13, 2020.

The following intakes were completed in this follow up inspection:

- Log #008143-19 for CO #001 from inspection report #2019_761733_0005 related to O.Reg 79/10, s. 15. (1) - the use of bed rails
- Log #013625-19 for CO #001 from inspection report #2019_625133_0014 related to O.Reg 79/10 s. 90. (2) - a bed system maintenance program

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Resident Assessment Instrument-Minimum Data Set (RAI-MDS) Coordinator, the Restorative Care Personal Support Worker (PSW), and residents.

During the course of the inspection, the inspectors reviewed several resident healthcare records in relation to bed rail use, reviewed documents related to bed system evaluations, reviewed bed audit and maintenance committee meeting minutes, reviewed documents related to bed system maintenance, reviewed service manuals for bed systems, reviewed the licensee's policies 'Bed Rail Minimization Program' last revised November 2019, and 'Bed Audit and Maintenance Program' last revised December 2019, observed residents' bed systems, and observed a bed system evaluation performed by the Restorative Care PSW.
