WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 57. Powers of Residents' Council Specifically failed to comply with the following subsections:

s. 57. (2) If the Residents' Council has advised the licensee of concerns or recommendations under either paragraph 6 or 8 of subsection (1), the licensee shall, within 10 days of receiving the advice, respond to the Residents' Council in writing. 2007, c. 8, s. 57.(2).

Findings/Faits saillants:

1. Although the Administrator responds to Residents' Council concerns, in writing, there is no documented evidence to support that the responses are provided to the Council within 10 days of receiving the concerns or recommendations. The Administrator confirmed that the responses are not dated and therefore, it is not evident that the responses are provided to Residents' Council within 10 days. [LTCHA, 2007 S.O 2007, c. 8, s. 57.(2)]

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 85. Satisfaction survey Specifically failed to comply with the following subsections:

s. 85. (3) The licensee shall seek the advice of the Residents' Council and the Family Council, if any, in developing and carrying out the survey, and in acting on its results. 2007, c. 8, s. 85. (3).

Findings/Faits saillants:

1. There is no documented evidence to support that the licensee seeks the advice of Residents' Council in developing and carrying out the satisfaction survey.

The Administrator acknowledged that the survey for 2012 was developed corporately and advice was not sought from the Residents' Council, in the development of the survey. [LTCHA, 2007 S.O. 2007, c.8, s. 85(3)]
