WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 73. Dining and snack service

Specifically failed to comply with the following subsections:

s. 73. (2) The licensee shall ensure that,

(a) no person simultaneously assists more than two residents who need total assistance with eating or drinking; and

(b) no resident who requires assistance with eating or drinking is served a meal until someone is available to provide the assistance required by the resident. O. Reg. 79/10, s. 73 (2).

Findings/Faits saillants :

1. The licensee failed to ensure that no resident who requires assistance with eating or drinking is served a meal until someone is available to provide the assistance required by the resident.

During the evening meal on Sunday Oct. 28, 2012, inspector observed resident # 2 with his/her main plate in front of him/her. The resident was not eating and not holding his/her cutlery. No one assisted the resident to eat until staff was questioned by inspector. Staff confirmed that the resident needs assistance to eat, and that the resident's meal was served to him/her 5 to 10 minutes prior to when staff began assisting the resident to eat.

On November 1, 2012 during the evening meal, resident # 3 was served his/her main plate at 1715h. The resident appeared unable to reach the plate or the utensils. At 1720h a staff member sat down beside the resident and began to feed the resident.

Written plan of care for resident # 3 indicates that the resident requires total feeding and that Health Care Aide (HCA) is to remain with the resident for meal duration.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that no resident who requires assistance with eating or drinking is served a meal until someone is available to provide the assistance required by the resident, to be implemented voluntarily.
