- s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:
- 11. Every resident has the right to,
- i. participate fully in the development, implementation, review and revision of his or her plan of care,
- ii. give or refuse consent to any treatment, care or services for which his or her consent is required by law and to be informed of the consequences of giving or refusing consent,
- iii. participate fully in making any decision concerning any aspect of his or her care, including any decision concerning his or her admission, discharge or transfer to or from a long-term care home or a secure unit and to obtain an independent opinion with regard to any of those matters, and
- iv. have his or her personal health information within the meaning of the Personal Health Information Protection Act, 2004 kept confidential in accordance with that Act, and to have access to his or her records of personal health information, including his or her plan of care, in accordance with that Act. 2007, c. 8, s. 3 (1).

- 1. The licensee of the long term care home did not ensure that the following rights of residents were fully respected and promoted: Every resident has the right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's dignity.
- In March 2012 the Registered Nurse (RN) and Personal Support Worker (PSW) entered resident #1's room to provide a treatment. The resident attempted to refuse the treatment however, the RN confirmed that despite the resident's efforts to stop the treatment, the procedure continued and documentation confirmed the treatment was provided. The RN confirmed that she had used the same procedure when providing the resident treatments previously and documentation confirmed the RN provided at least three treatments over two months. The RN confirmed that this procedure was intimidating for the resident and that it violated the resident's right to be treated with respect and dignity. [s. 3. (1) 1.]
- 2. The licensee of the long term care home did not ensure that the following rights of residents were fully respected and promoted: Every resident has the right to, give or refuse consent to any treatment, care or services for which his or her consent is required by law and to be informed of the consequences of giving or refusing consent. Resident #1 was resistive in efforts to stop a treatment being provided. The RN confirmed that despite the resident's verbal and physical actions to stop the treatment, the procedure continued until the treatment was provided and the resident's right to refuse treatment was not recognized by the staff. The Executive Director confirmed that when staff providing care were interviewed they were aware that the resident chose not to receive the treatment as a regular intervention. Documentation indicated that the RN had provided the resident a treatment three times in two months and the RN confirmed that she had repeatedly provided this procedure to the resident despite the resident's efforts to refuse the treatment. WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,
- (a) the planned care for the resident; 2007, c. 8, s. 6 (1).
- (b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).
- (c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

Findings/Faits saillants:

1. The licensee of the long term care home did not ensure that there was a written plan of care for each resident that set out clear directions to staff and others who provide direct care to the resident. The Executive Director stated that in 2012 staff were aware that it was resident #1's choice not to have a treatment however, the resident's plan of care in 2012 directed staff to follow the home's policy which included the treatment. A current physicians order indicated for staff not to provide the treatment however, the resident's current plan of care indicated for staff to follow the home's policy which included the treatment. WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records

Specifically failed to comply with the following:

- s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,
- (a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and O. Reg. 79/10, s. 8 (1).
- (b) is complied with. O. Reg. 79/10, s. 8 (1).

Findings/Faits saillants:

1. Where the Act or this Regulation required the licensee of the long term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee was required to ensure that the plan, policy, protocol, procedure, strategy or system, was complied with. The home's bowel protocol stated that if there was no bowel movement after 2 days then on day 3, staff were to give a laxative and if still no bowel movement then on day 4, staff were to give a laxative. The homes bowel protocol was not followed for resident #1 on two occasions over a one month period in 2012. Documentation indicated the resident did not have a bowel movement for five consecutive days however, documentation in the resident. The resident did not have a bowel movement for four consecutive days however, documentation in the resident's clinical record and the Executive Director confirmed that there were no interventions offered. [s. 8. (1) (b)]
