The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 30, 2014

During the course of the inspection, the inspector(s) spoke with the Executive Director, Director of Care, Associate Director of Care, and Housekeeping staff.

During the course of the inspection, the inspector(s) reviewed the home's housekeeping general cleaning procedures; cleaning and disinfection education and training documentation; content and completion of the Infection Prevention and Control Core Competencies course offered by Public Health Ontario completed by the home's leads in infection prevention and control; conducted a walk-through and inspection of resident home areas including janitor closets for availability of cleaning and disinfection supplies.

Specifically failed to comply with the following:

- s. 87. (2) As part of the organized program of housekeeping under clause 15 (1) (a) of the Act, the licensee shall ensure that procedures are developed and implemented for,**
(b) cleaning and disinfection of the following in accordance with manufacturer's specifications and using, at a minimum, a low level disinfectant in accordance with evidence-based practices and, if there are none, in accordance with prevailing practices:
(i) resident care equipment, such as whirlpools, tubs, shower chairs and lift chairs,
(ii) supplies and devices, including personal assistance services devices, assistive aids and positioning aids, and
(iii) contact surfaces; O. Reg. 79/10, s. 87 (2).

s. 87. (3) The licensee shall ensure that a sufficient supply of housekeeping equipment and cleaning supplies is readily available to all staff at the home. O. Reg. 79/10, s. 87 (3).

Findings/Faits saillants :

1. The licensee has failed to ensure that procedures are implemented in accordance with manufacturer's specifications, using at a minimum a low level disinfectant in accordance with evidence-based practices and, if there are none, with prevailing practices, for cleaning and disinfection of contact surfaces.

Interview with an identified housekeeper revealed that at a minimum a low level disinfectant was not in use for daily clean of resident bedrooms and washrooms as per the home's policy and procedures and prevailing practices. Observation of the housekeepers cart revealed the same. [s. 87. (2) (b)]

2. The licensee has failed to ensure that cleaning supplies are readily available to all staff at the home.

Interview with an identified housekeeper revealed that the housekeeper did not have access to the janitor closet located on their respective unit. As a result, the housekeeper could not refill or access additional cleaning and disinfection supplies and products on their unit and was required to access the products from another resident home area floor. **VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to**

- a) ensure that housekeeping staff are consistent in their practice of daily clean of resident home areas using at minimum a low level disinfectant on contact surfaces;**
- b) ensure that all staff, including housekeepers, have cleaning and disinfection supplies readily available to them at all times within their respective home area, to be implemented voluntarily.**
