1. The licensee had failed to ensure that the planned menu items were offered and available at each meal and snack.

The planned lunch menu for May 21, 2015, indicated that residents were to receive tomato rice soup, wieners and beans, chef's choice salad and corn muffin, however, corn muffins were not available for residents. Food Service Manager confirmed that due to short supply of ingredients in stock the corn muffins were not prepared and served for lunch; the menu item was taken off the lunch menu but no substitution was made and available. [s. 71. (4)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the planned menu items are offered and available at each meal and snack, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 73. Dining and snack service

Specifically failed to comply with the following:

s. 73. (1) Every licensee of a long-term care home shall ensure that the home has a dining and snack service that includes, at a minimum, the following elements: 9. Providing residents with any eating aids, assistive devices, personal assistance and encouragement required to safely eat and drink as comfortably and independently as possible. O. Reg. 79/10, s. 73 (1).

1. The licensee had failed to ensure that resident #002 was provided with eating aid and assistive devices, required to safely eat and drink as comfortably and independently as possible.

The plan of care for resident #002 indicated to provide assistive devices at all meals for beverages. During the lunch in May 2015, the resident received tray in their room and had beverages (milk and water) served in plastic glasses. The Director of Care confirmed resident was not provided with assistive devices as indicated in the plan of care. The focus statement for eating/swallowing indicated that the resident was risk for choking and aspiration, used assistive for beverages to safely drink. [s. 73. (1) 9.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the home has a dining and snack service that includes, at a minimum, the following elements: 9. Providing residents with any eating aids, assistive devices, personal assistance and encouragement required to safely eat and drink as comfortably and independently as possible, to be implemented voluntarily.
