The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): October 26, 27, 28 and 29, 2020.

The following Complaint intakes were completed within this inspection:

Log #019888-20 related to safe transferring and the prevention of staff to resident abuse.

Log #014068-20 related to resident's rights and resident service charges.

Log #020221-20 related to resident's rights, skin and wound care, pain management, food quality, nutrition care, hand hygiene and prevention of staff to resident abuse.

During the course of the inspection, the inspector(s) spoke with the Executive Director, the interim Director of Care (DOC), the Wound Champion/Team Lead, the Dietary Manager, a Registered Practical Nurse (RPN), a Personal Support Worker (PSW), a Public Guardian and Trustee (PG&T) and residents.

The inspector also observed resident rooms and common areas, observed medication administration, observed meal service, observed residents and the care provided to them, observed staff hand hygiene, reviewed health care records and plans of care for identified residents and also reviewed relevant procedures of the home.
