**During the course of the inspection, the inspector(s) spoke with the Executive Director (ED), Assistant Director of Care (ADOC), Acting Director of Care (DOC), RAI Coordinator, Food Service Manager, Resident Services Coordinator, Life Enrichment Supervisor, Registered Practical Nurses (RPN) and Personal Support Workers.**
