Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Ce qui suit constitue un avis écrit de non-respect aux termes du paragraphe 1 de l'article 152 de la LFSLD.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 73. Dining and snack service Specifically failed to comply with the following subsections:

- s. 73. (2) The licensee shall ensure that,
- (a) no person simultaneously assists more than two residents who need total assistance with eating or drinking; and
- (b) no resident who requires assistance with eating or drinking is served a meal until someone is available to provide the assistance required by the resident. O. Reg. 79/10, s. 73 (2).

## Findings/Faits saillants:

- 1. At lunch on February 28th, 2012 in the 3rd floor dining room three identified residents requiring assistance with eating were served soup in advance of assistance being provided.
- Resident A requiring total feeding assistance was served soup at approximately 12:10pm; assistance was not provided until 12:27pm
- Resident B requiring total feeding assistance was served soup at approximately 12:10pm; assistance was not provided until 12:21pm
- Resident C requiring supervision, oversight and cueing at meals was served soup at approximately 12:10pm while asleep at in his chair at his table. Resident continued to sleep until 12:28 when he was cued and awoken by staff.[r. 73. (2) (b)]
