**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s.  
15. Accommodation services**

**Specifically failed to comply with the following:**

- s. 15. (2) Every licensee of a long-term care home shall ensure that,**  
**(a) the home, furnishings and equipment are kept clean and sanitary; 2007, c. 8,  
s. 15 (2).**  
**(b) each resident's linen and personal clothing is collected, sorted, cleaned and  
delivered; and 2007, c. 8, s. 15 (2).**  
**(c) the home, furnishings and equipment are maintained in a safe condition and  
in a good state of repair. 2007, c. 8, s. 15 (2).**

**Findings/Faits saillants :**

1. The following areas of the home are not maintained in good repair:
  - missing seal around newly installed resident toilets was noted in seven identified resident washrooms. This was previously identified during inspection visit April 18, 2013.
  - caulking along the tops of vanity counters were noted to be cracked and/or not intact in four identified resident washrooms.
  - the exhaust was noted to be inoperable and/or blowing out air and not extracting air in two identified resident washrooms.
  - Wooden dining room and lounge area chairs and dining room table legs were noted to be worn and discolored in the 3rd floor and main floor dining rooms. [s. 15. (2) (c)]

**Additional Required Actions:**

*VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)  
the licensee is hereby requested to prepare a written plan of correction for  
achieving compliance to ensure toilets in resident washrooms are properly  
sealed following replacement as to prevent floor damage and potential odour  
concerns, to be implemented voluntarily.*
