The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 91. Every licensee of a long-term care home shall ensure that all hazardous substances at the home are labelled properly and are kept inaccessible to residents at all times. O. Reg. 79/10, s. 91.

Findings/Faits sayants:

1. Aug 23, 2011 - At 1130 hours, the spa room door was propped open with a wet floor sign. Staff were not near the area. Residents were walking in the hallways.

There were two bottles of tub cleanser observed on top of the tub and a bottle of wound disinfectant observed on top of the tub. A bottle of tub disinfectant was in unlocked cupboard.

A Personal Support Worker confirmed that this door was to be locked at all times when no one was in the room.

2. Aug 23, 2011 - 14:07 - The Assistant Director of Nursing confirmed that the spa room doors were to be locked at all times when staff were not using them.
