Findings/Faits saillants:

1. The licensee did not ensure that one resident's right to be cared for in a manner consistent with their needs was met. Review of one resident health care record identified family expressed verbal concern about the resident's health status twice within one and a half hours. The resident was not assessed by registered staff for three and one-half hours. Two staff confirmed a nursing assessment was not completed until three and one-half hours after the expressed concerns.
