WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 48. Required programs

Specifically failed to comply with the following:

s. 48. (1) Every licensee of a long-term care home shall ensure that the following interdisciplinary programs are developed and implemented in the home:

1. A falls prevention and management program to reduce the incidence of falls and the risk of injury. O. Reg. 79/10, s. 48 (1).

2. A skin and wound care program to promote skin integrity, prevent the development of wounds and pressure ulcers, and provide effective skin and wound care interventions. O. Reg. 79/10, s. 48 (1).

3. A continence care and bowel management program to promote continence and to ensure that residents are clean, dry and comfortable. O. Reg. 79/10, s. 48 (1). 4. A pain management program to identify pain in residents and manage pain. O. Reg. 79/10, s. 48 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure there was an organized falls prevention program required and that there is an interdisciplinary falls prevention and management program developed and implemented in the home, with the aim to reduce the incidence of falls and the risk of injury.

Responsive Management policy for Quality Management for Falls Prevention Program defines that the Director of Care performs an annual evaluation of the program and implements changes according to the best practices and identifies and assigns a Falls Prevention Coordinator; The Falls Prevention Coordinator identifies a Fall Prevention Champion if required and teaches the fall prevention program and acts as a "mentor" for staff.

Inspector interviewed direct care staff and they were not able to confirm that there was an active Falls Prevention Team in the home.

The Director of Care confirmed that there was not an active Falls Prevention Team in the home or active members on the team at the time of inspection to review incidence of falls and the risk of injury to residents in the home. [s. 48. (1) 1.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure there is an organized falls prevention program, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 221. Additional training — direct care staff

Specifically failed to comply with the following:

s. 221. (1) For the purposes of paragraph 6 of subsection 76 (7) of the Act, the following are other areas in which training shall be provided to all staff who provide direct care to residents:

1. Falls prevention and management. O. Reg. 79/10, s. 221 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure that staff are provided training for falls prevention and management.

The Executive Director was not able to confirm that the Falls Prevention and Management staff education was being provided annually to direct care staff.

The Executive Director confirmed that there was no record of staff that were trained on Falls Prevention training for all staff that provided direct care to residents. [s. 221. (1) 1.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance that staff are provided training in falls prevention and management, to be implemented voluntarily.
