- (c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

- 1. The licensee did not ensure that there is a written plan of care for each resident that sets out the planned care for the resident, the goals the care is intended to achieve and clear directions to staff and others who provide direct care to the resident.
- a) Resident #027 was admitted to the home with a physician's order for a special treatment.
- c) The written plan of care for the resident does not include the planned care for the resident, the goals the care is intended to achieve and clear directions to staff and others who provide direct care to the resident related to the special treatment.
- d) One staff confirmed the written plan of care does not include the special treatment. [s. 6. (1)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure the written plan pf care for the resident includes the planned care for the resident, the goals the care is intended to achieve and clear directions to staff and others who provide direct care to the resident, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 44. Every licensee of a long-term care home shall ensure that supplies, equipment and devices are readily available at the home to meet the nursing and personal care needs of residents. O. Reg. 79/10, s. 44.

- 1. The licensee has not ensured that supplies, equipment and devices are readily available to meet the nursing and personal care needs of the resident?
- a) Resident #027 was admitted to the home with a physician's order for a special treatment.
- b) The treatment equipment did not work properly and was replaced with a loaned device from an external service provider who then removed the device from the home approximately one week later.
- c) From the date the device was removed by the external service provider until the date of this inspection, the resident has not been provided with their special treatment.
- d) The treatment equipment is an eligible expense within the home's nursing and personal care envelope.
- e) Two management personnel confirmed they were researching alternate methods of funding with the resident's family.
- f) The resident shared with Inspector #144 that they were tired, weak and exhausted. [s. 44.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that supplies, equipment and devices are readily available to meet the nursing and personal care needs of the resident, to be implemented voluntarily.
