During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), Maintenance, Manager of Resident and Family Services, Registered Nurses (RN), Registered Practical Nurses (RPN) and residents. During the course of the inspection, the inspector(s) reviewed health care records of residents, reviewed infection surveillance records, reviewed staff training records, reviewed bed system audits, observed resident rooms/beds and measured lighting levels in corridors, resident rooms and bathrooms throughout the home.
