WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records

Specifically failed to comply with the following:

- s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,**
- (a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and O. Reg. 79/10, s. 8 (1).**
- (b) is complied with. O. Reg. 79/10, s. 8 (1).**

Findings/Faits saillants :

1. The licensee has failed to ensure the policy named "Compresses" LTCE-CNS-B-04, May 2012 was complied with. In 2014, a Registered Nurse performed a specific compress therapy to Resident #001.

The policy directed staff to perform checks every few minutes and this was not completed. The same policy also directed staff to document the clinical assessment and symptoms found in the resident record. The registered nurse did not follow the policy and complete this documentation.

The lack of documentation in the resident record confirmed the policy was not complied with. Interview with the Registered nurse and management team also confirmed the policy was not complied with.
