The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 5-9 and 12-13, 2021.

The following intakes were completed in this Critical Incident System (CIS) inspection:

Log #003032-21 was related to an injury with hospitalization.

Log #006125-21 was related to alleged neglect.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Co-Directors of Care, Assistant Directors of Care, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSWs), and residents.

During the course of the inspection, the inspectors observed resident and staff interactions, and infection prevention and control practices. They reviewed clinical health records, relevant home policies and procedures, and other pertinent documents.
