**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 101.
Conditions of licence**

Specifically failed to comply with the following:

s. 101. (3) It is a condition of every licence that the licensee shall comply with this Act, the Local Health System Integration Act, 2006, the Commitment to the Future of Medicare Act, 2004, the regulations, and every directive issued, order made or agreement entered into under this Act and those Acts. 2007, c. 8, s. 195 (12); 2017, c. 25, Sched. 5, s. 23.

Findings/Faits saillants :



1. The licensee has failed to comply with the following requirement of the LTCHA, 2007: it is a condition of every licensee that the licensee shall comply with every order made under this Act.

The following compliance order (CO #002) was issued under O.Reg. 79/10 s. 131(2) in Inspection Report #2018_597655_0019 (A1), dated February 11, 2019:

The licensee must be compliant with O. Reg. 79/10, s. 131 (2).

Specifically, the licensee shall:

1. Ensure that resident #006, #008, #010 and #011 receive their prescribed medications, in accordance with the directions for use specified by the prescriber. The compliance date was January 31, 2019.

Inspector reviewed the health records, including the electronic medication records from February 1st to March 3rd 2019, for residents #006, 008, #010 and #011. The licensee ensured that drugs were administered to residents #006, #008 and #010 in accordance with the directions for use specified by the prescriber.

Inspector reviewed resident #011 health record and noted that on an identified date, resident's physician prescribed a specific medication.

In review of the resident's progress notes, on an identified date, it was documented that the resident did not receive a specific medication at a specified time of day. A medication incident report was completed. The resident was assessed and there was no evidence of any adverse effects to the resident.

Inspector reviewed the medication incident report with the Director of Resident Services and they confirmed that on an identified date the resident was not administered their medication as specified by the prescriber. [s. 101. (3)]
