The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): December 20 and 22, 2016.

The purpose of this inspection was to provide a Follow Up Inspection to compliance order #001 (log 030328-16) relating to beverage and snack pass and compliance order #002 (log 030330-16) relating to the dining service. Both these compliance orders were issued during Follow Up Inspection #2016_450138_0032 conducted in September/October 2016.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Patient Food Services Manager, personal care attendants (PCAs), a food service attendant, a registered nurse, a registered practical nurse, and residents. The Inspector observed a morning fluid pass, an afternoon snack pass, a lunch meal service and a breakfast meal service on the sixth floor of the home. The Inspector reviewed resident weight records, reviewed food and fluid documentation records, and reviewed residents' dietary information.
