The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with LTCHA, 2007, S.O. 2007, c.8, s.10(1) Every licensee of a long-term care home shall ensure that there is an organized program of recreational and social activities for the home to meet the interests of the residents.

Findings:

- 1. The licensee failed to ensure there was an organized program of recreational and social activities for the home to meet the interests of the residents based on the following:
 - A schedule of recreation and social activities was not available for review by the inspector at the time of the inspection.
 - Inspector spoke with three staff members, including the DOC, who identified that currently the home does not have an organized recreational and social activities program.
 - Inspector interviewed a resident who identified there is no structured program for activities.
 This resident identified that previously activities were held in the home but it has been quite
 some time and that "this is just not fair". This resident also identified to the inspector that one
 PSW occasionally works part-time in the afternoons to provide one-to-one activities with
 residents however no activities occur in the evenings or on the weekends.
 - Inspector observed throughout the inspection residents sitting in the main lounge with the television on. Inspector did not observe any structured group activities for these residents.
