The purpose of this inspection was to conduct a Critical Incident System inspection.

During the course of the inspection, the inspector(s) spoke with residents, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), the RAI coordinator and the Director of Care (DOC).

A review of electronic records, investigation documentation and relevant Long-Term Care home policies including the OMNI Therapeutic Manual - Falls Prevention and Management Program and Achieva Health Falls Prevention Program was also conducted.
