The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): April 17, 18 and 22, 2013

During this follow-up inspection it was determined that a previously issued order (October 18, 2013) related to LTCHA 2007, c. 8, s. 19(1)- the licensee's duty to protect residents from abuse by anyone, was identified as compliant at the time of this inspection.

This follow-up inspection was conducted concurrently two complaint inspections #H-000175-13 and H-000175-13 as well as two critical incident inspections #H-000049-13 and H-001834-12. Three of these inspections were related to the treatment of residents and abuse. Information collected while conducting these inspections was used to make a decision to place the previously identified non compliance back into compliance.

During the course of the inspection, the inspector(s) spoke with residents, registered and unregulated nursing staff, the Director of Care and the General Manager in relation to Log # H-002214-12

During the course of the inspection, the inspector(s) reviewed records the home maintained related to actions taken to comply with the Long Term Care Homes Act and inspected one Critical incident and one Complaint related to abuse concurrently with this inspection.

There are no findings of Non-Compliance as a result of this inspection.
