During the course of the inspection, the inspector(s) spoke with Registered Nurses (RN), Registered Practical Nurses(RPN), Physician, Personal Care Aides(PCA), RAI Coordinator, Behavioural Support Team members(BSO), Housekeeping staff, Neighbourhood Coordinators, Assistant General Manager(AGM) and the Director of Nursing Care(DNC).
