The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with O. Reg. 79/10, s.8(1)(b). Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system, (b) is complied with.

Findings:

1. The Home's policy on Nutrition and Hydration was not complied with at the breakfast meal on October 14, 2010. The Home's Nutrition and Hydration policy (Tab 04-46) section 4. states: "PCA's will complete the Nutrition and Hydration Flow sheet in the dining room immediately following each resident meal to accurately record the amount of foods and fluids consumed by the resident". At 1000h on October 14, 2010 the breakfast meal information had not been entered into any of the four Home area's nutrition and hydration flow sheets.

Additional Required Actions:

VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance in ensuring the Nutrition and Hydration policy is complied with, to be implemented voluntarily.
