During the course of the inspection, the inspector(s) spoke with the QI Nurse (Infection Control Designate), registered and non-registered staff and Director of Environmental Services regarding indoor air temperatures and outbreak control measures.

During the course of the inspection, the inspector(s) toured the Rymal and Scotsdale home areas, took air temperatures and humidity readings, reviewed heating and ventilation service reports and air temperature logs, reviewed outbreak incident reports filed by the home to the Ministry with respect to any declared outbreaks in 2012 and reviewed the homes current outbreak control measures with the infection control designate.
