**Specifically failed to comply with the following subsections:**

**s. 31. (1) A resident may be restrained by a physical device as described in paragraph 3 of subsection 30 (1) if the restraining of the resident is included in the resident's plan of care. 2007, c. 8, s. 31. (1).**

**Findings/Faits saillants :**

Oct. 8, 2011 - The identified resident fell attempting to get out of resident's wheelchair by self.

Oct. 10, 2011 - The Dr. wrote an order for a treatment pertaining to the fall

The plan of care did not reflect the interventions/clear directions for the staff providing care relating to the Dr.'s order.

**Additional Required Actions:**

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance by ensuring the plan of care accessible to the staff providing care is current at any given time., to be implemented voluntarily.**
