The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): November 21, 22, 23, 2017

A complaint inspection (2017-561583-0012) was previously conducted on June 8, 2017, at which time two Orders were issued related to the licensee's maintenance of mechanical lift equipment and their investigation process following a report of failed or malfunctioning mechanical lift equipment. For this follow up inspection, the conditions laid out in the Orders have been addressed.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Environmental Services Supervisor and Personal Support Workers.

During the course of the inspection, the inspector toured four out of six home areas, reviewed maintenance request logs, mechanical lift equipment inspection reports (monthly and daily), service records, lift inventory list, staff training materials, staff training attendance and reviewed the licensee's investigative process for reports related to failed or malfunctioning lift equipment.
