During the course of the inspection, the inspector(s) spoke with the Administrator/Director of Care (DOC), the Clinical Coordinator, the RAI Coordinator, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers, the Registered Dietician (RD), residents and family.

As part of the inspection, reviews of electronic and hard copy health records were completed. Multiple interview(s) and observations of resident care and services were also conducted. In addition, physician orders, call bell response monitoring, medication administration records and relevant policies and procedures were reviewed.
