The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): November 29, 2017

A follow up inspection (2017-539120-0014) to a Compliance Order (previously issued on August 22, 2016) was conducted on February 23, 2017, related to the licensee's bed system entrapment evaluation program and staff training. During that follow up inspection, the conditions in the Compliance Order (CO) were met, however a separate CO was issued for non-compliance related to clinical assessments related to residents and the risks associated with bed rail use. For this follow-up visit, the conditions that were laid out in the CO have been complied with.

During the course of the inspection, the inspector(s) spoke with the Director of Care, Associate Director of Care, registered practical nurse and residents.

During the course of the inspection, the inspector toured the first and second floors of the home, observed resident bed systems and residents in bed, reviewed residents' clinical records, resident bed rail risk assessments, bed safety policies, procedures and associated forms
