WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 99. Evaluation

Every licensee of a long-term care home shall ensure,

- (a) that an analysis of every incident of abuse or neglect of a resident at the home is undertaken promptly after the licensee becomes aware of it;**
- (b) that at least once in every calendar year, an evaluation is made to determine the effectiveness of the licensee's policy under section 20 of the Act to promote zero tolerance of abuse and neglect of residents, and what changes and improvements are required to prevent further occurrences;**
- (c) that the results of the analysis undertaken under clause (a) are considered in the evaluation;**
- (d) that the changes and improvements under clause (b) are promptly implemented; and**
- (e) that a written record of everything provided for in clauses (b) and (d) and the date of the evaluation, the names of the persons who participated in the evaluation and the date that the changes and improvements were implemented is promptly prepared. O. Reg. 79/10, s. 99.**

Findings/Faits saillants :

1. The licensee has failed to ensure, that a written record of the names of the persons who participated in the evaluation of the home's Prevention of Abuse Program was promptly prepared.

A review of the home's annual evaluation of Prevention of Abuse program, dated January 14, 2017, revealed that there was no written record of the names of the persons who participated in the evaluation. The evaluation indicated only the administrator's name who completed this record.

A review of the home's policy #AD-1013-01, entitled, "Annual Evaluations- Care and Service Program", published April 1, 2016, indicated the Prevention of Abuse program will be evaluated annually through an appropriate inter-disciplinary team.

Interview with the Administrator revealed that the above mentioned evaluation was not completed by the formal interdisciplinary team. [s. 99. (e)]
