**The purpose of this inspection was to conduct a Complaint inspection.**

**Logs #026830-18 related to sufficient staffing, and responsive behaviour, #030012-18 related to falls, and duty to protect, #001438-19 related to resident to resident altercation.**

**A non-compliance identified for resident #003, under plan of care s. 6. (11) (b) was issued in Critical Incident System (CIS) inspection #2019\_766500\_0012, which was completed concurrently with this inspection.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Acting Manager Resident Services, Social Worker, Nurse Managers, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Recreational Services Assistant, Personal Support Workers (PSWs), and families.**
