(c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

Findings/Faits saillants :

1. The licensee failed to ensure that the written plan of care set out clear directions to staff and others who provide direct care to the resident #1.

- Resident #1 had a physician order in place for a therapeutic intervention.
- The resident's health record indicated the resident was non compliant with the therapeutic intervention.
- Interviews with staff report that they are unable to identify the required frequency for he treatment.
- There was no written plan of care developed to address the resident's need for the therapeutic intervention [s. 6. (1) (c)].

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the written plan of care sets out clear directions to staff and others who provide direct care to the resident, to be implemented voluntarily.
