WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 129. Safe storage of drugs

Specifically failed to comply with the following:

s. 129. (1) Every licensee of a long-term care home shall ensure that, (a) drugs are stored in an area or a medication cart,

(i) that is used exclusively for drugs and drug-related supplies,

(ii) that is secure and locked,

(iii) that protects the drugs from heat, light, humidity or other environmental conditions in order to maintain efficacy, and

(iv) that complies with manufacturer's instructions for the storage of the drugs; and O. Reg. 79/10, s. 129 (1).

(b) controlled substances are stored in a separate, double-locked stationary cupboard in the locked area or stored in a separate locked area within the locked medication cart. O. Reg. 79/10, s. 129 (1).

1. The licensee failed to ensure that drugs are stored in an area or a medication cart that is secure and locked.

On a specified date, during medication administration the following observations were made:

- A medication cart located on an identified unit was observed to be unlocked and unattended. The Registered staff assigned to the cart reported to the inspector that the cart has been malfunctioning over the duration of three days and could not be locked.

- The inspector reported the unlocked medication cart to the Nurse Manager and Administrator of the home who confirmed they were not made aware of the broken lock on the medication cart.

- A medication cart located on an identified unit was also observed to be unlocked and unattended. The Registered staff member assigned to the medication cart was not within close distance to the cart. During an interview the Registered staff member confirmed to the inspector that the medication carts are to be locked at all times when unattended [s. 129. (1) (a) (ii)].

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that drugs are stored in an area or medication cart that is secure and locked, to be implemented voluntarily.
