WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 65. No interference by licensee

A licensee of a long-term care home,

(a) shall not interfere with the meetings or operation of the Residents' Council or the Family Council;

(b) shall not prevent a member of the Residents' Council or Family Council from entering the long-term care home to attend a meeting of the Council or to perform any functions as a member of the Council and shall not otherwise hinder, obstruct or interfere with such a member carrying out those functions;

(c) shall not prevent a Residents' Council assistant or a Family Council assistant from entering the long-term care home to carry out his or her duties or otherwise hinder, obstruct or interfere with such an assistant carrying out those duties; and

(d) shall ensure that no staff member, including the Administrator or other person involved in the management or operation of the home, does anything that the licensee is forbidden to do under clauses (a) to (c). 2007, c. 8, s. 65.

1. The licensee failed to ensure that the licensee does not interfere with the meetings or operation of the Family Council. [s. 65. (a)]

An interview with the Family Council President revealed that on an identified date an email had been received from the home's Administrator instructing the Family Council to cancel the invitation for the guest speaker due to attend the a Family Council meeting. The Administrator indicated in the email that she would assist Family Council in developing the meeting agenda and that she would be in attendance to the next and all future Family Council meetings. An interview with the Administrator confirmed the information received and also indicated that she had removed the Family Council Notice of Meeting for an identified date which had been posted on the Family Council bulletin board. The Administrator confirmed her interference with the identified Family Council at the meeting. A review of the Family Council meeting minutes for an identified period of time confirmed information received.

The Family Council president indicated in an interview that the Family Council contact information had been changed within the 'Wesburn Manor News' monthly newsletter for an identified period of time without knowledge or approval by the Family Council. The Administrator revealed in an interview that an error had been made within the 'Wesburn Manor News' monthly newsletter for two identified months. The Administrator confirmed that the Family Council contact information had been entered incorrectly into the newsletter, which was an oversight by the home and the changes to the contact information had not been intended. The Administrator confirmed that the 'Wesburn Manor News' newsletter has been corrected with current Family Council contact information. [s. 65. (a)]
